ENTRY PROCEDURES

GENERAL: By entering the event all acknowledge and agree that they shall comply with the ITTF rules, regulations, policies, and additional requirements and procedures as issued by ITTF.

BEFORE TRAVELLING

Passports must be valid for at least 6 months from the date of arrival.

Check host country entry requirements and airline requirements (if applicable).

Check if you need a visa, If yes, please contact the LOC (contact: <u>paratennis rk@mail.ru)</u> to request visa support and an invitation letter for your visa application. Additionally, contact to the Kazakhstan Embassy in your country for further assistance.

Each member Federations is responsible for ensuring adequate insurance in the case of injury, illness, quarantine, repatriation, etc. of any member from their delegation during the event. All accommodation fees must be paid in advance of the event by bank transfer or in cash upon arrival based on a pre-agreed guarantee letter of payment with the LOC.

Entry to Host Country: All participants are responsible for adhering to the border entry requirements.
